- d) if we (or a third party) have a legitimate interest which is not overridden by your interests or fundamental rights and freedoms. Such legitimate interests will be administrative or operational processes within Soteco International and direct marketing.

## We use your Personal Data:

- to conduct business and deliver our product and service to you and/or the company you work or act for.
- to send you business related information, such as market and industry specific information;
- to send you invitations to meetings and marketing events;
- to conduct direct marketing for Soteco International products and services to your company and/or organization.
